NAudio LICENSE

Not part of our license, but commentary:

(For anyone who lives in their mother's basement and gets upset that there's a copyright notice in the BSD license we used, you don't understand the realities of existing IP law and you don't understand open-source licenses and playing in the real world. The creators of FeenPhone are anti-IP, but want people who develop software (and hardware) to be able to use and adopt our software. Companies don't know what to do with some punk rock "NO COPYRIGHT!" notice, it has no legal meaning in the real world, so they won't adopt your software. The copyright is less-limited by the clauses that follow it. And use of a standard and known license allows people who do play in the real world to have a non-ambiguous understanding of the license.)

We didn't use the GNU GPL license because it's not compatible with the Ms-PL license that covers the NAudio components. Worms!
